Tax deductions for research and development (R&D) and technological innovation (TI) aim to promote a change of the productive model and to improve competitiveness through innovation. According to Spanish laws, R&D tax deductions can be as much as 59% of direct expenses. With proper management, it is possible to reduce the full amount of corporate tax through a deduction that reaches 12% in TI projects.

We process the issuance of a **Reasoned Report** that will be binding for the tax authorities, qualifying the R&D&i activity and its associated expenses, obtaining legal certainty.

- Economic effects comparable to a subsidy, but not taxed.
- May be applied freely (in all types of fields of knowledge and expenditure volumes), and generally, without competitive concurrence, nor a predefined budget limit.
- Proportional to the R&D&i activities developed, and applied in the yearly corporate tax return, up to a certain limit of the amount.
- The deduction generated but not applied, may be applied in subsequent financial years, and even the payment of R&D&i deductions generated may be requested.

Under Spanish legislation, it is possible to obtain **bonuses on the corporate amount of Social Security contributions for research staff** exclusively assigned to R&D&i activities. This is a non-tax incentive, linked to the employment and job maintenance exclusively related to R&D&i activities.

- A 40% bonus is established for corporate payments of Social security contributions.
- Employees included in groups 1, 2, 3 and 4 of contributions in the General Social Security System employed full-time in R&D&i (minimum 85% of their time) are the subject of these incentives.
- Those entities that apply the bonus to the shares of ten or more researchers must provide a binding reasoned report, issued by the MINECO (Ministry of Economy, Industry and Competitiveness.







The aim of an audit is to issue a **professional technical opinion** on whether the annual accounts offer the true image of audited entity's equity, financial situation and results, in accordance with the applicable regulatory framework of financial information and, in particular, with the accounting principles and criteria contained therein.

The audited annual accounts offer **reliable information** to shareholders, assurance to the administrative authority and transparency to third parties. The auditing of annual accounts may be compulsory or voluntary.

Regulation 887/2006, of 21 July, which implements Act 28/2003, of 17 November General Law on Subsidies, in its art. 74.1 provides that in the audit of subsidies the auditor of accounts issues a report based on the review of the account with the scope determined in the regulatory bases of the subsidy.
